

## Splash Dash Aquathlon and Open Water Swim

The Splash Dash Aquathlon is on Sunday, September 6<sup>th</sup> at 8:00am at the Stonebridge Beach Club located at 6203 Virginia Pkwy in McKinney. This race will consist of 750 and 1500 meter open water swims, an aquathlon distance of 2M/750/2M, an aquathlon distance of 5K/1500/5K, and an open two person relay for the longer distance aquathlon only. The format for the aquathlons is run/swim/run. Wetsuits will not be allowed in the swims. This race is in preparation for the Stonebridge Ranch Triathlon on September 27<sup>th</sup>. Awards will go to the fastest overall male and female in all events as well as age group awards. The top 3 relay teams will receive awards. You must have a valid USAT card to participate in the aquathlons or purchase a one day membership for \$10 at packet pickup. For the open water swims, you may have a current USMS or USAT card to participate. Packet pickup will be at Kiefer Swim Shop located on Coit Rd in Plano and at Ck Sports located at Custer and 121 in McKinney Thursday, Friday and Saturday before the events.
