

## Spring Fling Aquathlon and Open Water Swim

The Stonebridge race series will also include three aquathlons and open water swims this year. The first aquathlon is Saturday, April 11<sup>th</sup> at 8:00am at the Stonebridge Beach Club located at 6203 Virginia Pkwy in McKinney. This race is in preparation of the King Tut Triathlon on the 19<sup>th</sup>. The format for the aquathlon is swim (500 meters) and run (5K). The open water swim is 500 meters. Wetsuits will be allowed in the swims due to water temperature in the lake. Awards will go to the fastest overall male and female in both events as well as age group awards. You must have a valid USATcard to participate in the aquathlon or purchase a one day membership for \$10 at packet pickup. For the swim only, you may have either a valid USMS or USAT membership card. Packet pickup will be at Kiefer Swim Shop located on Coit Rd in Plano and at Ck Sports located at Custer and 121 in McKinney on Thursday and Friday before the event.
